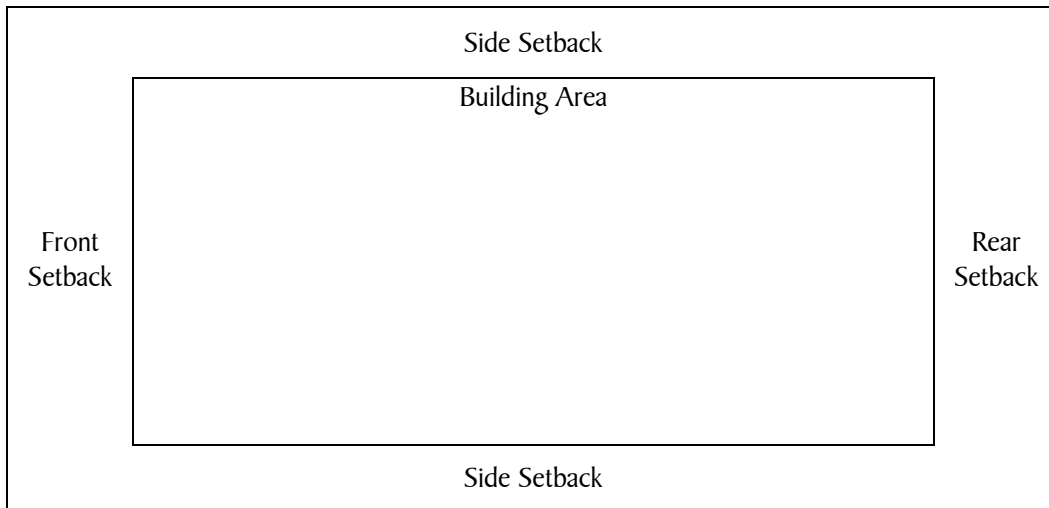
## TREE PERMIT APPLICATION SUPPLEMENT

This permit application is for the removal of tree(s) 8" in diameter and greater measured 4.5' above grade level and shall apply to the removal of trees associated with Routine Property Maintenance, Land Development Activities, and Emergency Removal as defined in WMC 16.12. For Routine Property Maintenance, the number of trees that may be removed on an annual basis and replaced are listed below and correspond to the zoning district in which the property is located. For Land Development Activities, only five percent (5%) of the trees located outside of the proposed building footprint, access and utilities easements can be removed per year and shall be replaced at a one to one ratio. This application shall be reviewed and approved by the Public Works Director pursuant to the provisions of WMC 16.12.
